### **SIGN UP for Face-to-Face Training and Online Poll Worker Training:**

Please go to <http://bit.ly/Zubky> to set up your account to login and select your session for face-to-face training. Once you login with the online site above, you will see ***Face-to-Face Training Sign Up*** using the button on the right. Pre-registration is not required for Face-to-Face training but signing up online will allow us to know of your plans to attend the required training for Election or Alternate Judges. The class will last approximately 2-1/2 hours.

**NOTE:** Poll Worker Handbooks may be picked up at ANY of the Face-to-Face Training classes. The Election or Alternate Judge may just sign in and request the number of handbooks needed for their poll workers. **NOTE: All election workers must be trained per state law.** If a worker has not trained in the last 12 months there are two options available:
